**Intentional attempted murder of a politically illegally persecuted invalid in need of care by means of severe mental and physical torture by the executive and judiciary of the FRG, on behalf of the legislature of the FRG.**

Dear Ladies and Gentlemen,  
Dear Mr Nils Melzer,

You are receiving this letter in English, as the official language of the United Nations, AND in German, my mother tongue. The purpose of this is, that my English is not so perfect that I partly resort to translation programs. But I am aware that there are also people working at the United Nations who can translate the relevant passages again in case of misunderstandings with my English. Thank you for your understanding.

I have already appealed to the UN several times with my urgent appeal for help. Because I, as an innocent politically persecuted invalid in need of care, am being deprived of any vested right by the FRG, but also by the EU. Thus, every legal remedy is denied in a perverse and criminal manner. It is clearly demonstrable that in the FRG and in the EU (which is already being dictatorially ruled by the FRG again, following the example of the years 1933 - 1945) there is no rule of law, no separation of powers, no free democratic basic order. In the FRG there is only a dictatorial judiciary swamp that bends, breaks and suspends all German and European and international law in order to maintain the untouchability of criminal judges.

41 I have been fighting against this criminal regime of the FRG and the EU for 13 years now. In  
42 the meantime, my state of health has taken on life-threatening exceptional proportions. The  
43 FRG and the EU are aware of this, but they continue just as they are. This proves that  
44 deliberate murder of my person is planned and decided here. And is also being carried out. By  
45 means of the most severe physical and mental torture.

47 **I have no more strength, I am on the verge of giving up.** Because I have neither national,  
48 nor international, nor even the UN Anti-Torture Commission to help me. I ask myself why  
49 such institutions exist. Just so that a lot of people can earn a lot of money without having to  
50 do justice to their mandate? Please excuse these nasty words, but I cannot explain it any other  
51 way.

52 **Please help me! I will also make suggestions further down in the letter on how you can**  
53 **help me.**

54 For health reasons, I am unfortunately not able to write in detail here again. But my  
55 documents should be available to the UN Anti-Torture Commission and also to Mr Nils  
56 Melzer. Nevertheless, I will briefly outline what is at stake here.

57 I am an incapacitated invalid in need of care, with 67% disability and care level 2. I suffer  
58 from two serious underlying diseases for which neither orthodox medicine nor the  
59 pharmaceutical industry are willing to research causal treatment methods. And this out of pure  
60 greed, without any consideration for the sick person. For one thing, I suffer from an  
61 inflammatory vascular disease called Winniwarter-Buerger. This disease is so rare that there  
62 is no research into causal treatment methods for this very reason. It is true that there is an  
63 institution in the EU called IMI, which is fed billions of euros by the Union states specifically  
64 for research into such rare diseases. But it has also been proven that this IMI passes the  
65 money on to the pharmaceutical industry unchecked, as illegal subsidies, so to speak, so that  
66 these pharmaceutical industries can develop new drugs for existing ones and thus earn even  
67 more. And the patients fall by the wayside of this perverse greed, which in this case is already  
68 highly criminal. But I am digressing from the topic. My second underlying disease is also an  
69 inflammatory disease. A rheumatoid polyarthritis. Both Winniwarter-Buerger, polyarthritis  
70 and other inflammatory diseases earn the pharmaceutical industry billions of dollars/euros  
71 annually worldwide through purely symptomatic treatment. The false statement is simply  
72 made that no treatment can be found for these diseases. Which is demonstrably an outrageous  
73 lie. Because if a causal treatment were found against these diseases, this industry would  
74 destroy itself 3-digit billion dollar earnings. The pharmaceutical industry is ONLY and  
75 EXCLUSIVELY interested in sick patients. Neither healthy nor dead people. And that is how  
76 they work.

77

78 I had no other option but to do my own research. Because the symptomatic treatment with this  
79 pharmaceutical chemical toxic waste was destroying my body and my health for good, I was  
80 forced to do my own research. Through self-experimentation to find out which side-effect-  
81 free treatment options were available that could also have a causal effect. Some of these self-  
82 experiments were also life-threatening. But did I have a choice? Besides, medical research is  
83 also expensive and I only have a small pension. For this reason, I wrote twice to both the big  
84 pharmaceutical companies and German federal ministries requesting financial support for my  
85 research. I didn't even get any replies. But later I realised that this was a big mistake, as it  
86 turned out.

87 In December 2015, I actually had a breakthrough in my research that would have justified  
88 clinical trials. And so it is no coincidence that in the context of an illegally constructed  
89 criminal case against me, only weeks later here in Spain, in illegally obtained administrative  
90 assistance, with the breach of numerous German and Spanish laws, a house search was carried

91 out on me in Spain. Mind you, without being able to present me with the requested search  
92 warrant. In other words, an armed robbery.

93  
94 As I found out later, the invalid search warrant issued by the criminal judge Wimmer of the  
95 Federal Supreme Court demanded that evidence and documents be seized proving that I had  
96 been involved in the logistics and financing of the internet forum in question. But the two  
97 criminal persons of the Federal Criminal Police Office who were unlawfully present at the  
98 robbery demonstrably had a different mission. A mission in the sense of the pharmaceutical  
99 lobby, which actually governs the FRG. Written documents were only half-heartedly checked.  
100 Due to the purchase of my raw materials for research, which admittedly were already quite  
101 close to the border of illegality, I could only settle them with anonymous payment methods.  
102 For this reason, I even had receipts from Pay-Safe-Card in my files. This was sifted through  
103 but NOT TAKEN. If the search had really been for the illegal process against me, this would  
104 have been such strong evidence that any criminal investigator would have been happy to have.  
105 Here they were not needed because the sole purpose of the robbery was to rob me of my  
106 medical research results. Which in my case led and still leads to me slowly losing the last  
107 vestige of my health. That I will not live much longer. That by now I don't even care if I die.  
108 Because due to the crimes of the fascist dictatorship in Germany, my pain is so great that  
109 death would be a release. And this is what the dictator Merkel, the potential murderer  
110 Steinmeier and their terrorist three powers are working on. I can clearly prove that this is a  
111 terrorist organization according to German law (§ 129a German Penal Code).

112  
113 Since January 2016, this terrorist FRG has been working to murder me by means of  
114 demonstrably severe mental and physical torture. I will gladly prepare the evidence if you  
115 agree to help me before I die as a result of the FRG's crimes. At the moment I really lack the  
116 strength to do so. This letter alone, up to this point here, has already taken me more than a  
117 week.

118 **I am really at the end of my powers.**

119  
120 I have tried to take legal action in the FRG. But this is blocked and denied to me. Because not  
121 only the culprits in the FRG cooperate, but all three powers in criminal and terrorist acts.  
122 Although the guilt of the perpetrators is clearly proven, investigations are denied. Because the  
123 perpetrators are public servants. Again, I have to stop here first, otherwise I will be insulting  
124 in the context of truth. Just one more thing:

125 Compared to these German judges as well as Judge Potocki at the European Court of Human  
126 Rights, the Nazi blood judge Freisler was a man of honour. Against the German medical  
127 experts, the Nazi doctor, Dr Mengele was a proper researcher. And that is a fact, that is not an  
128 exaggeration.

129  
130 I am a victim of the criminal regime of the FRG. Mrs Merkel, Mr Steinmeier, all Federal  
131 Ministers, the Petitions Committee of the Federal Government, all German public  
132 prosecutors, all German court presidents and many more have been fully informed by me  
133 about these terrible crimes against my health, my human dignity, my life and many other  
134 human rights. But ALL these persons cover up these crimes, although they would be obliged  
135 by law to intervene. This means that these persons, including Merkel and Steinmeier, are not  
136 only guilty of aiding and abetting by omission, but are definitely ringleaders. Incidentally, I  
137 am also denied the perpetrator-victim compensation in the FRG. Because in this regime, the  
138 protection of perpetrators is practiced when the perpetrators are public servants.

141 **How can YOU help me now?**

142

143 1. you can send me (which has never happened so far) a short written confirmation by e-mail (  
144 justizoper@bessere-welt.com ) that you have received my mail and are also willing to help  
145 me.

146 2. you certainly have contacts with Chancellor Merkel and President Steinmeier, in a way that  
147 the mail is not embezzled by their criminal employees. This embezzlement is punishable by  
148 law, but even a criminal complaint against it has been unlawfully rejected by the public  
149 prosecutors and the courts in Berlin. But Merkel and Steinmeier must be informed  
150 PERSONALLY. And above all, they must contact me personally to find a solution. And you  
151 can certainly establish this contact with me.

152 3. You can put pressure on the FRG regime to come to a perpetrator-victim settlement. I  
153 would even be prepared to accept that these FRG criminals would not be punished according  
154 to their deeds, if this victim-offender reconciliation would be according to my will. I simply  
155 want to have back the undamaged property that was stolen from me. So also my research  
156 results and treatment methods (which the FRG regime robbed from me on behalf of the  
157 pharmaceutical industry). One thing is clear, the lifetime robbed from me by these crimes in  
158 the last 5 years is lost, I cannot get it back. That is why my demands in the victim-offender  
159 settlement are not modest. Nevertheless, for the sake of peace, I would be prepared to forego  
160 punishing the perpetrators. Even though a trial at the ICC in The Hague for crimes against  
161 humanity and genocide would also be justified.

162

163 I would not hope that the UN would protect one of its members in its crimes just because that  
164 member is a paying member?????

166 **PLEASE HELP ME BEFORE IT IS TOO LATE**

168 With this letter you will first of all only receive the document about my absolutely bad state  
169 of health, for which the crimes of the FRG are solely to blame.
